## Puppy Contract

### 1. *Description of dog:*

### 2. *Consideration:*

This dog identified above is sold for the sum of \$ \_\_\_\_\_ to be paid in full upon pick at the kennel or before being shipped.

This dog, identified above has a balance of \$ \_\_\_\_\_ paid on \_\_\_/\_\_\_/\_\_\_ . \$300.00 was paid on \_\_\_/\_\_\_/\_\_\_ as a non-refundable deposit. Dog or bitch will be shipped to buyer when paid in full.

3. ***Cancellation made by the buyer:*** Non-Refundable \$300.00 deposit; an outright cancellation made by the buyer. The reason for this penalty is in direct relation to the support cost for the care and maintenance of the dog until a new owner becomes available. This is a good faith promise of your intent to purchase. A great deal of personal time goes into each puppy received. In the event of outright cancellation, all monies received by Giles Dobermans will be retained and used in direct relation to support cost and maintenance. **NO refunds in whole or part.**

4. ***Guarantee:*** The puppy that you have selected is guaranteed to be healthy at the time of purchase, to the best of our knowledge. To keep this guarantee in force, you must have your puppy examined by a licensed veterinarian of your choice with in four (4) days from the date of purchase. During the initial exam should your veterinarian find the puppy to be in poor health that would require further vet care, no fees charged for the initial examination or for any other veterinary services rendered will be paid by the seller. In the event your puppy does not pass his/her initial examination, he/she must be returned to the seller, along with the AKC registration papers and the examination results from a licensed veterinarian pertaining to the unsatisfactory health check during the four (4) day period. We reserve the right to obtain a second opinion with a veterinarian of our choice at our expense. A replacement puppy, either from the same litter or if not available then from a further litter, will be given to buyer. Your puppy will need additional vaccinations every two to three weeks until it is 16 weeks old. Then a booster is needed once a year.

**5. Stipulations:**

- (a) The buyer agrees that he/she is not acting as, or in part of an agent, in the purchase of this puppy and that the Buyer will not sell or give away this puppy or any of its progeny to any agent, pet store or guard dog business.
- (b) If the buyer chooses not to keep said dog, the seller will have first option to take the dog back at any point in his life, with no refund in whole or part. He is not to be sold without permission from the seller and is **NOT TO EVER BE GIVEN AWAY** under penalty of \$3000.00 fine.

**6. Limitations of Contract:**

This contract applies to the original puppy only and is non-transferable to a second party.

**7. Maintenance:**

- (a) Buyer agrees to maintain this dog in good health, provide routine preventative health care including, but not limited to, inoculations, internal and external parasites, and where required, heartworm preventative medication. The buyer agrees to maintain preventative care of the puppy in regards to hip dysplasia; such as proper nutrition, proper exercise and preventing stress injuries, (i.e. not allowing pup to jump from heights taller than itself at the shoulders). No forced exercise such as running until at least 12 months.
- (b) Buyer further agrees to provide proper exercise as indicated in order to maintain this dog or bitch in proper weight and physical shape. The pup must continue with an excellent diet **and requested supplement\* as a condition of this sale. Failure to meet these requirements will void all guarantees.**
- (c) Buyer agrees that this dog or bitch is **NOT** to be *LEFT INA BACKYARD OR KENNELS ONLY*. This dog or bitch is sold with the understanding that it was to go to selected homes and socialized properly, and the buyer **AVOWED** the dog or bitch would become a member of the family. (This is to assure proper development and maintenance of the temperament for which the animal was bred.) The Buyer agrees the puppy will reside at the home of the Buyer and have access to a fenced yard and not be chained or tied up.
- (d) Pet Prerequisites: All pet quality puppies (non Breeding) are placed with a limited registration. This means that AKC will not register any puppies from a limited registered dog nor are dogs with a limited registration eligible for breed competition (conformation).
- (e) All puppies purchased from Giles Doberman will carry the V Giles name (at the end of its name).
- (f) Please do not ask for full registration. None will be given.
- (g) Buyer agrees that seller will *REPOSSESS DOG OR BITCH UPON EVIDENCE OF NEGLECT AND /OR AB USE* at no expense to the seller with no refund in whole or part.
- (h) And finally, Buyer agrees that he/she understands this contract fully, and that this contract is under the jurisdiction of the State of Texas; in the County of Freestone. It is agreed the place of venue shall be in Freestone County, TX.

**\*\*REQUESTED SUPPLEMENTS**

**Pups must remain on puppy food for a period of one year.**

**Training treats and rewards:**

Rawhide, pig ears, or hoofs.

**HEARTGUARD or IVERMECTIN** - Once a month heartworm preventative, available from your veterinarian.
